2025 EXTENDED CALL FOR PAPER

Africa stands at the center of global attention due to its abundant natural resources, burgeoning markets, and strategic geopolitical position. Countries such as China, Russia, and those of the West have increased or sought to increase their engagement with the continent, offering investments, infrastructure development, and strategic alliances.

In the last few years, African countries have been reassessing the relationships with their foreign partners. Some countries have jettisoned old and hitherto established relationships and opted for new ones with the hope of a better live for their people and more development for the countries.

While these relationships bring opportunities for growth and development, they also present challenges, such as the risk of resource exploitation, debt dependency, and erosion of sovereignty. The reassessments and realignment of relationships seem also to present opportunities for a new renaissance in Africa.

This conference aims to provide a platform for African legal practitioners, policymakers, scholars, and stakeholders to critically analyse the role of foreign interests in shaping the continent's trajectory. The discussions will focus on harmonizing these engagements with Africa's aspirations for self-reliance, sustainable development, and economic integration under the African Continental Free Trade Agreement (AfCFTA).

18. **Family Law and Judgment Enforcement:**

SUBMISSION GUIDELINES

1. **Abstracts:**

Maximum of 300 words.

Include the title, author's name, affiliation, and contact information.

2. **Full Papers:**

Should not exceed 8,000 words (excluding references).

Must follow OSCOLA referencing guide.

3. **Format:**

Submissions in Word format (.docx).

4. **Language:**

Papers may be in English, French or Arabic.

5. **Extended Deadlines:**

Abstract Submission Extended Deadline: 10th July 2025.

Full Paper Submission Deadline: 22nd September 2025.
